Terms of Agreement:

1. This agreement shall become effective _____, and shall remain in effect until _____.
2. The Contractor affirms that a non-refundable payment in the amount of \$ _____ by: **check cc cash** has been made to MPW in consideration of its allowance to draw potable water from MPW fire hydrant(s).
3. To extend the use of a hydrant meter, a new contract must be completed, signed and payment must be received prior to the end date on the original contract, or the meter will be removed and a new application will be required.
4. During operation, MPW's Hydrant Meter Use Permit must be displayed at the usage site, on the vehicle or tanker.
5. Contractor will ensure their field staff will be trained in the proper operation of a fire hydrant.
6. Contractor will be responsible for any and all damage to private or public property as a result of operating MPW's hydrants and for any negligent damage to the assembly itself.
7. Contractor agrees to follow the applicable portions of MPW's Guidelines for Development in the execution of this Agreement. Failure to follow these requirements could result in penalties for unauthorized hydrant usage.
8. Contractor agrees to follow MPW Policy 4.6 Hydrant Use and Town of Mount Pleasant Code of Ordinances 51.014 Theft of Service.
